### Member Types and Qualifications

**Attorney**—Dues for attorneys and in-house counsel are based on a sliding scale, dependent on bar admission.

**Solo Practitioner**—An individual in private practice as a solo practitioner. Qualifies for discounted rates on programs and webinars and free PG roundtable discussions.

**Academician**—A full-time faculty at a law or graduate school. Receives access to all PGs. Qualifies for discounted rates on programs and webinars and free PG roundtable discussions.

**Government**—An attorney working in a public sector or government work setting. Receives access to all PGs. Qualifies for discounted rates on programs and webinars and free PG roundtable discussions.

**Paralegal**—An individual who has a title of, and works full time as, a paralegal. Benefits are delivered electronically. Qualifies for discounted rates on programs and webinars.

**Public Interest Professional**—An attorney or non-attorney who works in a nonprofit legal service agency, public interest law firm, nonprofit legal advocacy organization, or public health organization or agency. Qualifies for discounted rates on programs and webinars and free PG roundtable discussions.

**Non-Attorney**—Dues for non-attorneys are based on a sliding scale, dependent on college graduation date.

**Student**—Individual who is enrolled full time at a law or graduate school. Receives access to all PGs. Qualifies for discounted rates for programs and webinars and free PG roundtable discussions.

**Retired**—Member must be at least 60 years of age or older, have been an AHLA member for at least 20 years, and be retired from the practice of law. Qualifies for discounted webinar rates and free PG roundtable discussions.
